Ms. Wong has over 11 years of experience in financial reporting, auditing, financial management and internal control. Prior to joining the Group, Ms. Wong has taken up senior positions in several CPA firms in Hong Kong. Ms. Wong was also the assistant financial controller of a family office. After joining the Group, Ms. Wong was the person-in-charge of the Group’s GEM listing project during the listing process in 2018, covering different functions including finance and accounting, human

resources and administration. Ms. Wong obtained her bachelor's degree in Accounting and Accounting Technologies from Curtin University of Technology in January 2010. Ms. Wong is a member of Hong Kong Institute of Certified Public Accountants, CPA Australia and Association of Chartered Certified Accountants.
