發售價及配發結果公告

概要

發售價及所得款項淨額

- 發售價已釐定為每股發售股份0.30港元（不包括1.0%經紀佣金、0.0027%證監會交易徵費及0.005%聯交所交易費）。
- 按發售價每股發售股份0.30港元及總數為200,000,000股發售股份計算，經扣除包銷佣金及費用以及本公司就股份發售應付的其他估計上市開支後，本公司將收取的股份發售所得款項淨額估計為約34.3百萬港元。本公司擬按本公告下文「發售價及所得款項淨額」一段所載方式動用有關所得款項淨額。
